Requirements:

- A deposit of **\$100** is required to guarantee the date and time. The deposit will be applied towards the total amount. You may send your deposit by e-transfer to payment@hamptoncove.ca
- The number and list of players must be finalized 10 days prior to tournament date. You will be charged for the confirmed number.
- All signage and other course materials should be dropped off 2 days before the tournament.
- All contests must be approved to determine if extra tee times should be charged.
- 9 holes should take less than 2 hours and 3.5 hours for 18 holes. To keep the group moving, we ask that each group play with at least 1 experienced golfer as many participants tend to be new or inexperienced. Any group falling behind will be asked to move forward.
- Proper conduct is expected by all participants. Players should adhere to course rules, replace divots, repair ball marks and rake sand traps. Disruptive behavior, foul language, golf cart abuse, club throwing and hitting into groups will not be tolerated. Any player that chooses to not adhere to rules of conduct will be asked to leave the premises.
- You agree to exercise extreme caution when operating equipment (specifically but not limited to golf carts) and utilizing golf course property. In the event that you cause damage to the property and/or equipment used by your participants, you agree to pay us in full for any damages.
- All alcohol must be purchased from The Links at Hampton Cove. Alcohol brought in will be confiscated.
- The FINAL PAYMENT must be made on or before the tournament date.
